## **YOUTH AGE GROUPS**

**A Class** born between 01.01. 2003 and 31.12.2004

**B Class** born between 01.01. 2005 and 31.12.2007

**C Class** born between 01.01. 2008 and 31.12.2010

**D Class** born between 01.01.2011 and 31.12.2014

**Note:** To ride a Combustion engined machine the rider must have attained 6 years.

**E Class** Minimum age - 4 years and born after 01.01.2015.

**Note:** The rider must have attained 4 years at the date of Registration.

### **ENGINE CAPACITY /WHEEL SIZE FOR ABOVE AGE GROUPS:**

The maximum permitted for machines used in the Age Groups set out in this Regulation are as follows:

**A Class** 125cc Mono or 250cc Twinshock\*\* combustion engine, and Electric up to 10bhp measured at the rear wheel.

**B Class** 125cc Mono or 250cc Twinshock\*\* combustion engine, and Electric up to 10bhp measured at the rear wheel.

\*\* Twinshock machines over 125cc must have twin rear suspension units and drum brakes as at the time of manufacture.

**C Class** 80cc combustion engine, and Electric up to 7bhp measured at the rear wheel.

**D Class** 80cc combustion engine, Maximum Medium wheel. and Electric up to 7bhp measured at the rear wheel.

**E Class** Small wheel Electric powered machines up to 2bhp measured at the rear wheel.

**For competition purposes the C and D Classes may be split by wheel size.**

C Class Standard Wheel.

Medium Wheel.

D Class Medium Wheel.

Small Wheel.

### **Wheel sizes**

Standard Wheel - 21" Front - 18" Rear

Medium Wheel - 19" Front - 17" Rear

Small Wheel - 16" Front - 14" Rear

The above is based on the wheels of combustion engined machines using motorcycle tyres. If other wheels are used as on current Electric powered machines then the outside diameter (total circumference) of the tyre must not exceed that of the corresponding tyre size.

## TERMS AND CONDITIONS

All Users/Riders must be a current member of Moto Trial NI and must have attended an induction session.

No ID No Practice. Membership card must be carried at all times. Numbered Identification Bib must be worn at all times.

Only Trials Motorcycles fitted with Trials Tyres and meeting the current FIM noise limit of 90dB/A will be permitted in the Trial Bike Area.

All Users/Riders must ensure that their motorcycle is in a safe usable condition.

Users/Riders must Sign On prior to practicing and Sign Off when they are finished. The sign on time period will be clearly displayed, any User/Rider not signed on by the end of this period will not be allowed to practice.

**Youth Users/Riders MUST be accompanied AT ALL TIMES by a Parent or Guardian.**

All Riders/Users must wear a suitable Helmet and Boots.

Using the Whitespots Trials Park outside of the allocated times for Trials use is prohibited and will result in disciplinary action.

Courtesy must be shown at all times to other park users.

Riding in prohibited areas as shown on the park map will result in disciplinary action.

**Riding in the car park is not allowed.**

Any User/Rider found to be in contravention with any of the Terms and Conditions will receive a written warning and their details passed to the Council and PSNI. If found to be in contravention again they will have their pass confiscated for a period of time deemed to be appropriate by the Committee.
